NEW Workshop for APRNs for 2013

“APRN Licensure and Practice in Texas: Meeting the Challenges, Meeting the Needs”

Tuesday, October 29, 2013 (7:30am – 4:30pm)

This new all-day workshop will provide information regarding the nursing licensure laws that serve as the foundation for the APRN’s practice in the State of Texas. Workshop participation will contribute to the APRN’s ability to understand and follow the Texas nursing licensure laws, which in turn will promote the Board’s mission to protect and promote the welfare of the public. Key concepts that will be highlighted throughout the workshop will include an overview of the Texas Board of Nursing, APRN licensure requirements, Prescriptive Authority, Scope of Practice based on Education and Certification, Principles of Ethics, Standards of Practice, Unprofessional Conduct, and Core Standards for Advanced Practice.

While this new APRN workshop is not mandatory for licensure; APRNs will find the presentation informative and beneficial to their nursing practice. Nursing contact hours have been applied for through the Texas Nurses Association, an accredited approver of continuing nursing education by the American Nurses Credentialing Center's Commission on Accreditation.

“Advanced Practice Registered Nurse Application Process”

The webinar will describe the nursing laws and rules and regulations required for an APRN to obtain licensure along with prescriptive authority requirements, certification requirements, collaborative agreements, eligible sites, population focused practice and APRN practice under the Nurse Licensure Compact.

“Texas Board of Nursing Standards for APRNs”

Wednesday, August 14, 2013 (11:00am – 12:30pm)

This webinar will discuss the Standards of Nursing Practice, Unprofessional Conduct, and the Core Standards for Advanced Practice. Board staff will share case scenarios from closed disciplinary action files to illustrate key concepts that all APRNs should know and recognize. The cost for Individuals is \$25.00. Groups are \$200.00 up to 10 participants, and \$25.00 for each additional participant.

On-Line Nursing Jurisprudence Exam Prep Course

The Nursing Jurisprudence Exam Prep Course is an interactive instructional venue and offers an overview of the five subject areas of the nursing jurisprudence exam. Participants are able to complete practice questions, print resources to aid study, and look-up information for further review. The course is not only for exam preparation but also assists nurses in the review of the Nursing Practice Act and Board Rules and Regulations. The cost of the course is \$25.00 and is available to participants for three weeks.

On-Line Nursing Jurisprudence Exam

The Texas Nursing Jurisprudence Exam (NJE) is required for nurses who are applying for initial licensure and for individuals who endorse into Texas. The NJE contains 50 items and allows individuals two hours to complete. A passing score is 75%. Individuals taking the exam are permitted to access the BON website and other resource material throughout the exam to locate the answers to questions.
