

Promoting Competency Report

The Texas Board of Nursing's educational offerings and continuing nursing education (CNE) courses provide nurses with an opportunity to increase their knowledge of the laws and rules and regulations that affect their nursing practice and contribute to their continuing competency. These offerings and CNE courses are a high priority for Board staff and support the Board's mission of patient safety.




