

## **Nurse Licensure Compact Update**

### **Nurse Licensure Compact (NLC)**

The mutual recognition model of nurse licensure allows a nurse to have one license (in his or her state of residency) and to practice in other states (both physically and electronically), subject to each state's practice laws and regulations. Under mutual recognition, a nurse may practice across state lines unless otherwise restricted. In order to achieve mutual recognition, each state must enact legislation or regulation authorizing the Nurse Licensure Compact. States entering the compact also adopt administrative rules and regulations for implementation of the compact. Once the compact is enacted, each compact state designates a Nurse Licensure Compact Administrator to facilitate the exchange of information between the states relating to compact nurse licensure and regulation. On January 10, 2000, the Nurse Licensure Compact Administrators (NLCA) were organized to protect the public's health and safety by promoting compliance with the laws governing the practice of nursing in each party state through the mutual recognition of party state licenses. The Executive Director of the Texas Board of Nursing serves as the Compact Administrator for Texas.

### **NLCA Meetings**

The Nurse Licensure Compact Administrators (NLCA) and the NLCA Executive Committee (NLCA EXEC) meet regularly via teleconference and face to face at least twice a year. The last face to face meeting of the NLCA took place on August 12, 2014 in Chicago. Items considered on the agenda included review of revisions to the Nurse Licensure Compact, presentations from Federation of State Medical Boards, the Federation of State Boards of Physical Therapy, the National Association of State EMS Officials, and the Association of State and Provincial Psychology Boards on their progress with Interstate Compacts, and update to the Strategic Plan.

### **Delegate Assembly Adopts Resolution to Support Interstate Practice**

A review and revision of the Nurse Licensure Compact is underway but was not ready for consideration at the 2014 Annual meeting. The Delegate Assembly affirmed its commitment to facilitating interstate practice through adoption of a resolution. ### **New Compacts in Development**

The National Association of State EMS Officials is developing an interstate Compact "to solve the problem associated with day-to-day emergency deployment of EMS personnel across state boundaries." This Compact is scheduled to be developed by the end of 2014. The Interstate Compact for Physician Licensure draft changes have been unveiled. In a July 25, 2014 press release, the Federation of State Medical Boards (FSMB) noted changes to the interstate compact for physician licensure draft. Three proposed changes to the FSMB Compact draft include: requiring compact license applicants to submit to fingerprinting and background checks; clarifying that specialty board requirements with time-unlimited certification are also eligible; and passage of each component of the U.S. Medical Licensing Examination (USMLE) or the Comprehensive

Osteopathic Medicine Licensing Exam (COMLEX-USA) within three attempts. The FSMB notes that these changes to the draft Compact would strengthen physicians' licensure eligibility requirements and help ensure the safety of patients while in a physician's care. When the Compact is finalized, medical boards will decide whether to endorse the Compact and send it on to their state legislatures.

### **APRN Compact**

The Executive Officers and legal counsel of states who have passed the APRN Compact and states interested in joining the APRN Compact has been meeting since April 2012 to draft a new APRN Compact, rules and Uniform Licensure Requirements to conform to the national APRN Consensus Model and to add enforcement and rule making provisions to strengthen the Compact, see:

The new draft APRN Compact was presented by the Texas BON Executive Director at the August 2014 NCSBN Annual Meeting and Delegate Assembly. Although the Board of Directors initially recommended adoption, a decision was made prior to the meeting to postpone to align the new draft Nurse Licensure Compact with the APRN Compact and vote of both documents together.

### **Compliance Committee**

The Texas Compact Administrator co-chairs the Compliance Committee. The committee continues to refine new Compliance policies, develop flow charts for use of the new policies, and refine the self-audit tool. The Committee is working with Nursys staff to develop an automated audit process through the Nursys data base. This audit will assist Compact Administrators in assuring compliance with the Compact.

### **Participating States**

The Nurse Licensure Compact (NLC) has now been implemented in 24 states: Arizona, Arkansas, Colorado, Delaware, Idaho, Iowa, Kentucky, Maine, Maryland, Mississippi, Missouri, Nebraska, New Mexico, New Hampshire, North Carolina, North Dakota, Rhode Island, South Carolina, South Dakota, Tennessee, Texas, Utah, Virginia and Wisconsin.
