# Consideration for Change of Approval Status from Conditional to Full Approval Hill College Hillsboro, Texas Associate Degree Nursing Education Program

# **Summary of Request:**

Consider a proposed change in the program approval status for Hill College Associate Degree Nursing (ADN) Education Program in Hillsboro, Texas, from Conditional Approval to Full Approval based upon review of the 2015 NCLEX-RN® examination pass rate, the 2014 Nursing Education Program Information Survey (NEPIS), and Board Rule 215.

### **Historical Perspective:**

- Hill College was established in 1923. The college is a comprehensive community college and is accredited by the Southern Association of Colleges and Schools.
- Hill College has operated a successful Vocational Nursing (VN) Education Program since 1975. The Board approved the Associate Degree Nursing Education Program as a Licensed Vocational Nurse (LVN)-to-ADN program in 2006. A Paramedic-to-RN transition track was added in 2007, and a generic ADN Program was established in 2010.
- Lori Moseley, MSN, RN, Dean of Instruction, Health Science has served as Director of the ADN Program since 2007and meets all qualifications set forth by Board Rule 215.6 Administration and Organization.
- The NCLEX-RN® examination pass rates for the past six (6) years are provided in the following table:

- Subsequent to the program being placed on Conditional Approval at the January 2015
   Board meeting, the program was prohibited from enrolling new students.
- Hill College administration provided multiple resources to the ADN Program to provide guidance to the Program Director and faculty members in identifying measures designed
- The corrective measures implemented in the 2013 Self-Study Report SSR included:
  - o Admission criteria were reviewed and the preadmission testing scores raised.
  - Retention strategies with the Statewide At-Risk Tracking and Intervention for Nurses (SATIN) grant were reviewed to increase critical thinking skills.
  - More experienced adjunct faculty were being used in specialty areas such as pediatrics, mental health, and obstetrics.

- o Faculty were encouraged to increase use of active learning strategies in the classroom.
- o A full-time Nursing Success coordinator was hired.

#### Rationale for Staff Recommendations:

The program has demonstrated a pass rate for first-time candidates of at least 80% on the 2015 NCLEX-RN® examination and is currently in full compliances with Rule 215. Since the program has met rule requirements, the change of approval status will allow the admission of new students.

# **Staff Recommendation:**

Move to change the approval status for Hill College Associate Degree Nursing Education Program in Hillsboro, Texas, from Conditional Approval to Full Approval (See Attachment #1).
