

## **Status Report on Programs with Sanctions**

### **Background on Approval Status:**

- A new nursing education program is placed on Initial Approval following approval by the Board. The program may be moved to Full Approval when a cohort of students graduates, the program is in full compliance with Board rules, and the first NCLEX® examination pass rate is at least 80%.
- The approval status of a program on Initial Approval status will be changed to Initial Approval with Warning if the program is not in compliance with Board rules and if the first two years of NCLEX® examination pass rates are below 80%.
- A program will remain on Full Approval based upon compliance with Board rules, NCLEX® examination pass rates of at least 80%, and other pertinent information (such as accreditation status or complaints about the program).
- The approval status for a program on Full Approval will be changed to Full Approval with Warning if the program is not in compliance with Board rules and the program experiences NCLEX® examination pass rates below 80% for two consecutive years.
- The approval status for a program on Full Approval with Warning, or Initial Approval with Warning, will be changed to Conditional Approval if the program has serious compliance issues or if the program experiences NCLEX® examination pass rates below 80% for three consecutive years.
- A change in approval status is made by a decision of the Board.
- The examination year for professional nursing education programs is October 1<sup>st</sup> through September 30<sup>th</sup>.
- The examination year for vocational nursing education programs is January 1<sup>st</sup> through December 31<sup>st</sup>.

Data in the following table reflect changes in approval status made at the July 2017 Board meeting.
