

## **Consideration of Appointment of New Advisory Committee on Education Members**

### **Summary of Request:**

Consider the Staff recommendation regarding nominations for committee members for the Advisory Committee on Education (ACE).

### **Historical Perspective:**

In accordance with Board Rule [211.6.\(f\)\(1\)\(B\)](#), ACE advises the Board on education and practice issues that have or may have an impact on the regulation of nursing education in Texas. Board Staff anticipate ACE will be meeting to advise on education issues following the legislative session.

The Advisory Committee on Education has not met since September of 2015. In preparation for the anticipated ACE meetings, nominations were received from:

- The Texas Association of Vocational Nurse Educators (TAVNE);
- The Texas Association of Deans and Directors of Professional Nursing Programs (TADDPNP);  
and
- The Texas Organization of Baccalaureate and Graduate Education (TOBGNE).

Board Staff have reviewed the credentials of each nominee and concluded that each individual is fully qualified to fulfill the role and responsibilities associated with ACE membership. A summary of each nominee is included in Attachment "A".

### **Staff Recommendation:**

Accept and approve the following nominations for ACE membership:

- Korbi Kidd Berryhill, MSN, RN, CRRN representing TAVNE Community College Vocational Nursing Education programs;
- Cheryl Livengood, MSN, RN replacing Marla Erbin-Roesmann, PhD, RN to represent TADDPNP; and
- Marla Erbin-Roesemann, PhD, RN replacing Sharon Wilkerson, PhD, RN, CEN, ANEF to represent TOBGNE.

### **ACE Nominee Biographical Summaries**

- Korbi Kidd Berryhill, MSN, RN, CRRN, who is nominated to represent TAVNE Community College Vocational Nursing Education programs, is an active TAVNE member. Ms. Berryhill has extensive experience in vocational nursing education as Director of the South Plains College Vocational Nursing Program, a role she has held since 1996. Her clinical background includes administrative and direct care roles in rehabilitation, emergency, medical-surgical, and outpatient nursing. Ms. Berryhill is an active member of Sigma Theta Tau and the West Texas Alliance for Simulation through Application and Partnership.
  
- Cheryl Livengood, MSN, RN, who is nominated to represent TADDPNP, is an active TADDPNP member and the current President-elect. Ms. Livengood has been the Director of the Weatherford College Associate Degree Nursing Program since 2004, and served as the Nursing Department Chair from 2007-2010. She also held the Cisco Junior College Associate Degree Nursing Program Coordinator position from 2000-2004. Her clinical background includes over 20 years of administrative and direct care roles at Hendrick Medical Center. Ms. Livengood is a member of the Board Task Force to Study Implications of Growth of Nursing Education Programs in Texas, as well as several professional nursing and community organizations
  
- Marla Erbin-Roesemann, PhD, RN, who is nominated to represent TOBGNE, is an active TOBGNE member and President-elect. She served as ACE Chair representing TADDPNP from 2015 to 2017. Dr. Erbin-Roesemann is currently Director of the St. David's School of Nursing and the Associate Dean for the College of Health Professions. She has extensive experience in baccalaureate and graduate nursing education, research, and practice. She has published in several peer reviewed nursing journals and has been awarded many substantial grants and awards. Dr. Erbin-Roesemann is actively engaged with several professional associations and community organizations.
