Amendment to Agreement

This Amendment, (hereinafter referred to as the "Amendment") is made and entered into this 3/5 day of August, 2017, by and between the Texas Board of Nursing, having an address at 333 Guadalupe St., Suite 3-460, Austin, Texas 78701, and Precision Micrographics & Imaging, Inc., having an address at 8204 N. Lamar Blvd., Suite C-20, Austin, Texas 78753, collectively referred to as "Parties."

WHEREAS, the Parties have entered into a certain Services Agreement dated June 16, 2017, (hereinafter referred to as the "Agreement") for the following purpose: to provide digital imaging services to the Texas Board of Nursing, and

WHEREAS, the Parties hereby agree to amend the said Agreement in accordance with the terms and conditions contained in this Amendment and pursuant to Sections A.44 and B.3.1 of the RFP No. 507-17-139.

NOW THEREFORE, in consideration of the mutual promises and conditions contained here under and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1.

**AMENDMENT:** The parties agree that the Agreement is hereby modified and amended as follows:

It is agreed that the following two (2) line items will be included as part of the Contractor's Pricing Submission in response to RFP No. 507-17-139:

1. Conversion of up to legal size paper documents to 16mm microfilm (\$0.034/image).
2. Acid-free boxes for storage of 16mm microfilm (\$0.99/box) as needed.

**TERMS & CONDITIONS:** The parties agree that all of the terms and conditions of the original Agreement, not amended by this Amendment, shall remain in full force and effect as originally written. Should it at any subsequent time appear that these modifications to the Contractor's Pricing Submission conflict with relevant provisions of State law, the Texas Board of Nursing reserves the right to alter this amendment to insure its conformity with State law.


